## TEMPORARY SIGN PERMIT APPLICATION

## **Explanation:**

Signs of a temporary nature, as defined in Chapter 10-19 of the City ordinance, require filling out the permit below and receiving approval from the Community Development Department, prior to placement of the sign. Remember, no signs are allowed within the City right-of-way. Signs classified as "Temporary" include, but are not limited to the following:

- •Commercial Banner: (Max. 24 weeks per year/Min. 2 weeks/Up to 32 sq. ft./1 per event)
- Community Banner: (Max. 30-days/possible extension allowed/Up to 60 sq. ft./1 per event)
- •Bankruptcy: (Max. 90-days/1 display per business license)
- •School Signs on Fences Facing a Public Street: (<10% of fence/Up to 18 sq. ft./Min. 6' apart)
- Yard/Garage Sale: (Max.10-signs/Up to 4 sq. ft./5 straight days/15 days per year total)
- Open House: (Max. 10 signs prop. owner/3-signs Relators, etc./Max. 3 days/Up to 4 sq. ft./Max. 3 signs)
- Property Sale: (Max. 60-days/possible extension allowed/Up to 4 sq. ft./Max. 3 signs)
- •<u>Seasonal Business</u>: (14 straight days/Max. 60 days per year total/Up to 12 sq. ft./Max. 5 signs/Post only in commercial zones)
  - 1. All temporary signage is to comply with the regulations of Chapter 10-19 of the City ordinance.
  - 2. A Citation may be issued for each sign that is in violation.
  - 3. No off-premise signs are allowed in the city.
  - 4. Please provide the addresses or a map of the locations chosen for placement of the signs.
  - 5. A Sticker, provided by the City, shall be applied to each temporary sign or such sign will be considered invalid, and may be removed by the City.
  - 6. A \$50.00 fine may be issued for each sign in violation. See City Ordinance Section 10-19-18.
